## ORDER VACATING ROAD

Now on this 27th day of January, 1962, at a regular session of the Board of County Commissioners of Douglas County, Kansas, comes on for consideration and hearing by said Board the matter of vacation of a public road within said County described as follows, to wit:

Beginning at the Quarter Corner on the South Line of Section One (1), Township fifteen (15 South, Range Eighteen (18) East, thence West one-half  $(\frac{1}{2})$  mile to a point thirty-three (33) feet East of the Southwest Corner of Section 1-15-18.

The Board finds that notice of the proposed action has been given in the manner prescribed by law and that an order should be entered vacating said road.

The Board specifically finds that the construction and opera-tion of a military facility by the United States has rendered said road unusable and unsafe for public travel, and that it is not a public utility by reason of present neglect and disuse.

It is, therefore, ordered that the above described road be, and it is hereby, vacated in accordance with Section 68-102 of General Statutes Supplement 1959.
