> The Honorable Mayor Members of the City Commission The City Manager

We are fully aware that we are County Commissioners elected to administer County Government and County affairs. We are also vitally interested in the growth of the City of Lawrence, its uniform development, its beauty and appearance.

In the past there has been a most friendly relationship and wonderful cooperation between the governing bodies of the city and the county. We are now negotiating with the city to widen East Park Street to improve parking conditions in this area, and to participate equal in the cost.

We have never crossed the street to the City Hall but one time in the past to offer criticism of the action taken by the City Commission, and you can be assured that any criticism we might offer will be constructive.

At a meeting of your Commission, you voted to widen the shortest block on Massachusetts Street, namely, the area between 11th Street and Park Street. It is our desire to protest such action as not conforming with the other part of our main street and creating an unsightly spot in that location. We would like the opportunity to explain our position.
