The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board present.

Road and bridge matters were discussed with the County Engineer, Casey Rice.

Motion was made by Mr. Kampschroeder, seconded by Mr. Booth, and passed unanimously, that the County Engineer, be authorized to publish for bids on road project #F-1 32-691.

Motion made by Mr. Booth, seconded by Mr. Kampschroeder, that provided we enter into an agreement for the construction or repair of the bridge across the Kansas River at Eudora, it will be the policy of the Board to finance the project by using the present bridge fund, and, in addition, make a levy on all property in Douglas County as provided in 68-1135 Gen. Statutes of Kansas, 1949. Motion carried unanimously.

It was moved by Mr. Booth, seconded by Mr. Kampschroeder, that the Engineer be instructed to purchase 150' of 48" concrete pipe at \$11.60 per foot. Motion carried unanimously.
