NOW THEREFORE BE IT RESOLVED that it is necessary and

advisable to construct a main trunk line sever or severs as hereinafter described and along the following lines:

- 2 -

A 24-inch main trunk sewer connecting to the existing sever system of the City of Lawrence, Kansas, at 19th Street and extending southward along the Santa Fe tracks to 23rd Street and a 10-inch main sewer from 23rd Street eastward in the right of way of 23rd Street to Haskell Avenue.

BE IT FURTHER RESOLVED that there is hereby created a

main sewer benefit district, the boundary of which shall be as

follows:

Beginning 1657.14 feet north of the southeast corner of Section 6, Township 13 South, Range 20 East, thence west along the north line of a 5-acre tract lying adjacent to and north of East View Subdivision to centerline of Moody Road; thence north along centerline of said road to the easterly prolongation of the north line of Lot No. 1 East View Subdivision No. 2; thence west along said pro-longation and north line of Lots 1 and 9 to the east line of the Atchison, Topeka and Santa Fe Railroad right-ofway; thence southerly along said right-of-way to the easterly prolongation of the north line of Lot 12 Evergreen Addition; thence west along said prolongation and north line of Lots 12 and 11 to the northwest corner of Lot 11; thence south along the west line of Lots 11 and 8 to the southwest corner of Lot 8; thence west along the south line of Lot 7, a distance of 55.16 feet; thence south to the northwest corner of Lot 9, Block 2 India Addition; thence south along the west line of Lots 9, 8, 7, and 6 of Block 2 India Addition and continuing south to the north line of Lot 6, Block 1 India Addition; thence west along said line to the northwest corner of said Lot 6; thence south along the west line of said Lot 6 and continuing south to the north line of Section 7, Township 13 South, Range 20 East; thence east along said section lime to the east line of the Atchison, Topeka & Santa Fe Railroad rightof-way; thence south along said right-of-way line, a distance of 336.2 feet; thence east to the northwest corner of a 10-acre tract owned by Ira T. and Myrtle E. Hird; thence south along the west line of said tract, a distance of 323.8 feet; thence east, parallel to the north line of Section 7, to the west line of Section 8, Township 13 South Range 20 east; thence continuing east and perallel to the north line of Section 8, a distance of 990 feet; thence north to the south line of Section 5, Township 13 South, Range 20 East, a distance of 660 feet; thence east along said section line, a distance of 330.7 feet; thence morth to a point on the east line of an 8.995 acre tract caused by George D. and Hamel Smith, a distance of 591.04 feet; thence westerly to a point on the east line of Haskell Avenue right-of-way located 200 feet month of the montheset corner of Lot 8 Co-op Subdivision; thence continuing westerly to the east line of Section 6; thence month to the point of beginning.
