## R E S O L U T I O N

AND WHEREAS, this Board finds and determines upon the basis of an engineering and traffic investigation that the speed limit for the following described county road or highway, to-wit:

Beginning at a point 660 feet East of the  $\frac{1}{4}$  corner on the North line of Sec. 31-12-18 which is the East line of the Stull community, thence East on the Section line 4.5 miles to a point 660 feet East of the N.W. corner of Section 36-12-18 (intersection with Kansas Highway 40) called Kanwaka corner.

as set by K.S.A. 8-532, is greater than is reasonable or safe under the conditions found to exist on the above described county road or highway under the jurisdiction of this Board.

BE IT NOW THEREFORE RESOLVED by this Board of County Commissioners of Douglas County, Kansas, that a speed limit of 50 miles per hour be and the same is hereby determined and declared to be a reasonable and safe speed limit for the above described county road or highway. This speed limit shall become effective when appropriate signs giving notice thereof are erected upon the county road or highway above described.

AND WHEREAS, this Board of County Commissioners of Douglas County, Kansas finds and determines upon the basis of an engineering and traffic investigation that the speed limit for the following described county road or highway, to-wit:

Beginning at the Shawnee County line which is the N.W. corner of Section 26-12-17 in Douglas County, Kansas, thence East  $\frac{1}{4}$  mile, thence South on the section line one (1) mile, thence East on the Section line 1.6 miles to the West line of Stull community (West end of bridge across a branch of Deer Creek), or 660 feet East of the N.W. corner of Sec. 31-12-18.

as set by K.S.A. 8-532, is greater than is reasonable or safe under the conditions found to exist on the above described county road or highway under the jurisdiction of this Board.

BE IT NOW THEREFORE RESOLVED by this Board of County Commissioners of Douglas County, Kansas, that a speed limit of 30 miles per hour be and the same is hereby determined and declared to be a reasonable and safe speed limit for the above described county road or highway. This speed limit shall become effective when appropriate signs giving notice thereof are erected upon the county road or highway above described.
