R E S O L U T I O N

AND WHEREAS, K.S.A. 79-2801 requires that in all cases in which real estate has been or shall be sold and bid in by the County at any delinquent tax sale, and shall remain unredeemed on the first day of September of the third year after such sale, or any extension thereof as provided by Section 79-2401a of the General Statutes Supplement of 1947 or any amendments thereto:

AND WHEREAS this Board finds that there is such real estate having an aggregate of assessed valuation of ten thousand dollars (\$10,000.00) or more;

BE IT NOW THEREFORE RESOLVED by this Board of County Commissioners of Douglas County, Kansas, that the County Attorney of Douglas County, Kansas, shall institute an action in the District Court of Douglas County, Kansas, in the name of the Board of County Commissioners of Douglas County, Kansas, against the owners or supposed owners of such real estate and all persons having or claiming to have any interest therein or thereto to enforce the lien of Douglas County, Kansas, for unredeemed real estate bid in by the county by a judicial fore-closure and sale of said real estate by Douglas County, Kansas.
