Now on theis 22nd day of December, 1965, at 10:00 o'clock a.m., the Board of County Commissioners of Douglas County, Kansas, met in regular session in the Commissioners Offices in the Court House in the City of Lawrence, Douglas County, Kansas, with the following members present and participating, to-wit: Walter Kampschroeder, Harvey Booth and Elmer Ousdahl. The meeting was called for the purpose of answering any questions that interested property owners in the district might have relative to the creation of the district and the construction of the main sewer. Those present were: Mr. Leland Armstrony, Mrs. S.R Reynolds, Mrs. M.M. Dunigan, Mr. R.J. Rh and Mr. W.G. Neider. Charles D. Stough, Attorney for the Board and Jack Robinson, consulting engineer with Black & Veatch, were also present. Those R.J. Rhea. Charles D. Stough explained the legal steps involved in ;the creation of the district, and Mr. Robinson placed a large map on the wall and explained the preliminary engineering involved in the construction of the project. It was pointed out that the City of Lawrence was constructing at its own expense a sewage pumping station at the approximate cost of \$200,000.00, and other improvements within the City so that the sewage from the proposed Wakarusa Sewer District could be treated. It was further pointed out that noneof the costs of the treatment would be borne by the County Mr. Robinson, and the attorney were questioned concerning the method of assessment, and they advised the owners present that first a district would have to be created by the Board of County Commissioners. Following the creation of a district, a contract would be let for construction of the improvements when plans and specifications were ready. After all costs were determined, the property would be appraised by appraisers appointed by the Board of County Commissioners, who would then set valuations upon the land, which would be the basis for the special assessments. That special assessments would be spread over twenty years, or could be paid in a lump sum at the election of the property owner. That prior to the approval of the appraisers' report notice would be given all property owners and they would have an opportunity to be heard before the Board of County Commissioners, on the matter pertaining to the appraisal. After that hearing, the Board would order the assessments spread as

The group was further advised that the completion of the sewer was approximately a year away, assuming legal and engineering steps were taken with dispatch, and that bonds would probably not be issued for at least two years.
