It was moved by Mr. Kampschroeder, seconded by Mr. Glass, that the Douglas County Commissioners adopt a Resolution dated June 28, 1967, pertaining to the construction of a bridge located at Lecompton, Kansas, cost of such bridge to Douglas County not to exceed one million one hundred thousand dollars (\$1,100,000.00), election on this resolution to be held August 8, 1967. Motion carried unanimously.

AND WHEREAS, the Board does now find and determine that it is necessary to build a bridge at the following described location, to-wit:

> Beginning on the South bank of the Kansas River at approximate location of where Carrieve Street extended would intersect the Kansas River, in the City of Lecompton, Douglas County, Kansas, thence in a Northeast direction across the Kansas River, said bridge to be approximately 1200 feet down stream from present bridge location, and to connect with the existing Jefferson County Road south of Perry, Kansas,
