AND WHEREAS, this Board has agreed with the Board of County Commissioners of Jefferson County, Kansas, that the cost of such bridge should be prorated between the two counties on the basis of Douglas County, Kansas, paying eighty-one per cent and Jefferson County, Kansas, paying nineteen per cent;

AND WHEREAS, the Douglas County prorated share of the cost of building said bridge is estimated to be ONE MILLION ONE HUNDRED THOUSAND DOLLARS (\$1,100,000.00);

AND WHEREAS, under K.S.A. 68-1106, before making the appropriation for such bridge it must be submitted to the qualified voters of Douglas County, Kansas, at either a general or special election;

BE IT NOW THEREFORE RESOLVED by the Board of County Commissioners of Douglas County, Kansas, that an election is hereby ordered in accordance with K.S.A. 68-1106, on the above proposition, said election to be held August 8, 1967.

The Board of County Commissioners of Douglas County met in regular adjourned session, with all members of the Board being present.

Approved the minutes of the meeting of June 30, 1967.

The Board discussed County Road problems with the County Engineer, particularly in reference to the right-of-way problems on County Road FAS 1375. It was moved by Mr. Glass, seconded by Mr. Kampschroeder, that the Chairman of the Board of County Commissioners shall send a registered letter to the owners of the 31 tracts of land involved in the necessary right-of-way needed for road FAS 1375, advising them that if the necessary right-of-way cannot be obtained by July 20, 1967, the project shall be abandoned. Motion carried.

It was moved by Mr. Kampschroeder, seconded by Mr. Glass, that the County Zoning Administrator be authorized to purchase a desk and chair from Lawrence Typewriter for the sum of \$228.00. Motion carried.

The Board met with Ray Wells, Lawrence City Manager, to discuss the procedure and time schedule of a proposed bridge to be located in Lawrence, Kans. The City Staff and County Engineer to meet with representatives from Finney and Turnipseed, Consulting Engineers, Topeka, Kansas, and advise County Commissioners on July 7, 1967, as to availability of Finney and Turnipseed to make feasibility and location study for proposed bridge. Cost of study to be borne 50-50 by County and City of Lawrence.
