Approved the minutes of the meeting of July 3, 1967.

It was moved by Mr. Glass, seconded by Mr. Kampschroeder, that the public notice of a Special Election for a bridge near Lecompton, Kansas, as prepared by the County Clerk, be approved for publication in all three county papers, starting July 13th. Motion carried unanimously.

A discussion was held concerning the wage schedule and classification of County Employees. In order to clearify the policy, the following motion was made. It was moved by Mr. Booth, seconded by Mr. Glass, that the last paragraph of a resolution dated February 6, 1967, be amended to read as follows: After sufficient service the employee shall be paid at least the minimum set forth in his wage scale bracket. The wage scale bracket covering the years of service is to compensate the more efficient and exceptional employee. Any increase within the wage scale bracket will be considered only on January 1st of each year and then may be approved only after a request is submitted to the Board of County Commissioners by the Head of the Department and such request is found justified. All such requests shall be submitted in writing, list all the employees in the office, their terms of service and present rate of pay. Upon receipt of the above described request, the Board of Commissioners will aither allow or refuse the requested increase.

Mr. Booth and Mr. Glass voted in favor, Mr. Kampschroeder against. (County Clerk shall distribute a copy of this motion to each of the elective and appointed County Officers.)

The Board received report from Frank B. Cross, Director State Biological Survey, concerning test-netting done at Lone Star Lake, June 14-16, 1967. It was recommended by Dr. Cross that the feeding of channel cat fish in the rearing pond be terminated for at least one year and to make improvements on the rearing pond. Also, that a stock of white bass or other predators that attain large size be obtained. Dr. Cross to advise any sources for predator type fish that may be purchased commercially.

It was moved by Mr. Glass, seconded by Mr. Booth, that a request by the County Clerk for a wage increase for employee Dorothy Baldwin be denied. Mr. Glass and Mr. Booth voted in favor.
