Received appraiser report on the County owned property at Vinland and Lone Star, also lots 73,75,77,79,81 & 83 in Block 21, in West Lawrence, Douglas County, Kansas. It was moved by Mr. Glass, seconded by Mr. Booth, that the County Clerk proceed under KSA 19-211 to dispose of the land located at Lone Star and the vacant lots in West Lawrence. Said sale to be held during December, conducted by Mike Murphree, Auctioneer, and to be a public auction at the Courthouse; be legally advertised and further advertised by sending a notice to each realtor in Douglas County and to Attorney John Brand, representing the Medical Arts Center. Motion carried.

Board received bids on a proposed bridge $1\frac{1}{2}$ miles West and $\frac{1}{2}$ mile South of Stull, the following bids were received on the project, known as 15.46-1.0,

Constant Construction Co.	\$15,316.75
B.A. Green Construction Co.	24,481.70
Engineers Estimate	18,276.25

It was moved by Mr. Glass, seconded by Mr. Kampschroeder, that the bid of Constant Construction Co. be accepted, and a contract awarded by the County Engineer. Both bidders to be thanked for submitting a bid. Motion carried.

Board received petition signed by 23 property owners in Douglas County, requesting improvement of F.A.S. Route 1375, East of Highway U.S. 59, for a distance of five (5) miles. County Engineer advised to hold petition pending further action.

It was moved by Mr. Kampschroeder, seconded by Mr. Glass, that a contract be entered into with the Treanor Company, for treatment and service, and inspection of the boiler in the Courthouse. Said contract to be for an annual charge of \$105.00. Motion carried.

No further business, the Board adjourned to meet on Monday, Nov. 20th.

Board met with representatives of the Schlup, Becker & Brennan, Consulting Engineers, concerning a proposed agreement with Douglas County for a Kansas River bridge study at Lawrence, Kansas. Proposed agreement referred to County Attorney for a decision on the legality and form of agreement, then to be returned to the Board for action.

Board met with Mr. H.H. Belote to discuss the furnishing of ambulance service in the County and area surrounding Lawrence. Discussion in furtherance of request made November 1, 1967. Mr. Belote advised to secure a certified audit of his operations within Douglas County only, and his request for a subsidy would be reconsidered.

No further business, the Board adjourned to meet on Wednesday, Nov. 22nd.
