County Assessor, Darwin Rogers, appeared before the Board to discuss the hiring of extra help during the peak period of work in his office. It was moved by Mr. Glass, seconded by Mr. Kampschroeder, that the assessor be authorized to hire help with no experience at the rate of \$250.00 per month and persons with experience at up to \$275.00 per month. Motion carried.
