Mr. Belote further stated that he would make his financial records available, if the County desired to pay the cost of a certified audit.

Dr. Dale Clinton, City-County Health Officer, appeared before the Board to discuss the status of the City-County Health Board. Dr. Clinton advised that he had served as Director for some seven (7) years and that he felt relations during this period had been good and he cannot see any need for a change in the present arrangement.

Board discussed zoning matters with John Clyatt, Zoning Administrator.

Commissioner Cancellation Orders No's 497, 498, 499 & 500 were approved by the Board and signed by the Chairman. Orders are on file in the office of the County Clerk.

It was moved by Mr. Kampschroeder, seconded by Mr. Glass, that the County Engineer be authorized to advertise for bids for 3 large dump trucks and 1 pickup truck. Bids to be received at 10:00 A.M., December 27, 1967. Motion carried.

County Engineer discussed the rock requirements of the Road & Bridge Department, for 1968, with the Board. Engineer advised he would need 30,000 tons of rock to replenish stock pile material. No action taken.

Board received opinion from the County Attorney in reference to ambulance service for Douglas County. No action taken.

Board received opinion from the Attorney General, pertaining to the possibility of the Sheriff, Undersheriff, or a Deputy Sheriff, serving as Civil Defense Director of the County. Such joint position is not recommended by the Attorney General.

Mr. Frank Bradley, C.P.A., appeared before the Board along with the County Treasurer, to discuss the policy of securing deposits of funds by the County Treasurer. The County Attorney shall be requested to secure an opinion on the question from the Attorney General.

Mrs. Cerf and Mrs. Twente, appeared before the Board to discuss the County Rest Home situation. Ladies appeared as representatives of the League of Women Voters, and offered the services of the League to conduct a study of the County needs. No action taken.

Mr. Charles Stough, Attorney, appeared before the Board to discuss matters pertaining to Main Benefit Sewer District No. 10. It was moved by Mr. Glass, seconded by Mr. Kampschroeder, that Resolution No. 127, fixing costs and apportioning the same for the improvement of Wakarusa Main Benefit Sewer District No. 10, of Douglas County, Kansas, be approved. Motion carried. Publication of Resolution and notice of special session to hear any complaints, to be held at 10:30 A.M., December 27, 1967, was approved.

No further business, the Board adjourned to meet on Friday, December 8th.
