Group of citizens from West of Lawrence, appeared before the Board to discuss the City landfill area, west of Lawrence, and the operation of the same. Group was invited to wait for the arrival of the Lawrence City Manager, at 10:00 A. M. Mr. Wells and Mr. Williams, Public Works Director, appeared and explained the operation of the landfill, and the plan to stop the fire and smoldering of the material. Also, steps to be taken to stop trash along roads and blowing material.

Board met with City Manager, Ray Wells, and Public Works Director, to discuss road improvements proposed for Haskell Ave., south of 23rd Street. It was moved by Mr. Kampschroeder, seconded by Mr. Booth, that the County Engineer be authorized to contact the State Highway Commission and advise them that Douglas County will be interested in the widening of Haskell Ave. from 23rd Street south, for a distance of 500 feet. Motion carried.

County Engineer was directed to meet with the City Engineer and City Planner, to discuss various road improvements, adjacent to the City of Lawrence. Group to report back to Commissioners at 10:00 A. M. February 26, 1968.

No further business, the Board adjourned to meet on Wednesday, Jan. 24th.

The Board of County Commissioners of Douglas County met in regular adjourned session, with all members of the Board being present.

Approved the minutes of the meeting of January 22, 1968.

Commissioners Cancellation Order No. 524 was approved by the Board and signed by the Chairman. Order is on file in the office of the County Clerk.

Board received application from Wesley Kabler, for a license to sell cereal malt beverages at the Flamingo, 501 North 9th, Lawrence, Kansas.

Board instructed caretaker at Lone Star Lake, to plainly mark buildings No. 9 - 10 - 12 - 13 - 15 - 16 & 18 at the Lake. It was moved by Mr. Kampschroeder, seconded by Mr. Booth, that the County Clerk be instructed to advertise for sale the above numbered buildings. Bids to be on an individual building basis, and to be opened on February 14, 1968, at 10:00 A. M. Buildings to be removed by April 1, 1968. Motion carried.

Board discussed Welfare problems with John Derrick, Welfare Director, including present and proposed wage scales of employees. Board approved salary increase for Director based on Civil Service requirements and length of service. Board established regular meeting dates of 11:00 A. M. on the 2nd & 4th Wednesdays of each month.

Board met with the County Assessor and County Zoning Administrator, to discuss the appraisal and assessment of new real estate within the County. Assessor reported that during 1967 there were 155 completed residential assessments within the City of Lawrence; that presently there are 208 permits still pending. Also, there are 21 business permits yet to be processed plus 9 new permits and 1 business permit in Baldwin. Addition to business's in Lawrence, 12 pending, 5 additions still pending in the Townships, and 124 addition permits still pending. Board advised the Zoning Administrator to start immediately to devote one half of his time to assessment and he and the Assessor to report back to the Board on Wednesday, February 14, 1968.

No further business, the Board adjourned to meet on Friday, Jan. 26th.
