The Board approved a resolution dated February 2, 1968 directing the County Clerk to issue a license to sell Cereal Malt Beverages to Gregory J. Roth, Rt. 3, Lawrence, Kansas.

Mike Murphy and Kenny Goll appeared before the Board to question the erection of a structure for boarding horses. There was some question regarding the number of feet the building should have been located from the lot lines. No action was taken and the problem was referred to the County Attorney for recommendations.

TAX SALE

The Commissioners discussed with the County Attorney the procedure to be followed in the delinquent tax sale scheduled for Spring of 1968. The County Attorney is to make arrangements for the abstraction of the tax list, and advise the Board who will be responsible for the abstraction, and suggest to the commissioners the terms of employment for the abstractor.

ASSESSMENT OF
STUDENTS

The County Assessor appeared to discuss the problem of assessment of out of state and international students who own automobiles in Kansas, but because they are not Kansas residents, are not assessed for personal property tax. The problem arises when these individuals attempt to purchase car license tags without proof of taxes being paid. The tax assessor is to study specific statutes relating to tax assessment of international students.

EUDORA BRIDGE
JETTIES

Bob Schellack appeared to discuss with the Board the repairs to jetties on the north bank of the Kansas River by the Eudora Bridge. This is in compliance with an agreement signed by the Douglas County Commission and Corps of Engineers. It was the responsibility of Douglas County to maintain these jetties. The matter was referred to the County Clerk and he was advised to find record of any such agreement.

LAWRENCE BRIDGE

Mr. Schlup, Mr. Becker, Mr. Al Horn of Schlup, Becker & Brenham, Consulting Engineers, discussed engineering problems of the proposed Kansas River Bridge at Lawrence. The firm was asked to send a representative to appear before a joint meeting of the Lawrence City Commission and the Douglas County Board of Commissioners to be held Wednesday, February 7, at 7:00 a.m.
