POPERTY ACQUISITION The Board received a letterifrom Mr. and Mrs. Ralph E. Sullivan with a proposal to sell their SULTUAN property adjacent to the Court House to the County. The Board wrote to them requesting permission to have the property appraised from the interior as well as the exterior.

The Board requested an opinion from the County Attorney concerning whether or not the Courty could contract Leonard Williams - a retired public employee - to do some work for the County without putting his retirement allotment in jeopardy.

ELOORA BRIDGE The Board requested an opinion from the County Attorney concerning whether or not it was Iouglas JE TIES County's responsibility to maintain the jetties on the north bank of the Kansas River near the Eudora Bridge since the new Bridge has been built.
