#543

ROCK SPRING LAKE
FISHING

George Schlecty appeared with Bill Cole, Biologist for Fish and Game Department for Northeast Kansas, and Dr. Frank Cross to give a report concerning fishing conditions at Lone Star Lake. The recommendations offered were to drain the lake, or to poison the fish and then restock. The possibilities of fertilization were also discussed. The Commissioners requested that a written copy of the report and recommendations be submitted for further study and consideration.

Tommie McGee submitted to the Board the survey of the property line of Mr. Johnson at Lone Star Lake to determine the extent to which the dog pens are on County Property. The Sheriff and Zoning Administrator are to consult the County Attorney to verify the legal process by which these kennels may be removed from County property.

SEWER
COST OF EASEMENT
DIST. 10

In reply to the question asked by Mr. Jack Brand on March 1, Mr. Stough reported that the cost of easement on Sewer District #10 was between 50 and 60 cents per foot. Mr. Stough was instructed to submit in writing an estimated cost of easement per foot on Sewer District #10 and the number of feet on the property of Mr. Gad Smith who is represented by Mr. Brand.
