COUNTY WELLS

The Board discussed the County Wells. It was moved by Mr. Booth and seconded by Mr. Kampschroeder that the Board authorize Mr. Swank to put the Rappard Well at the Lyons farm into working order at an estimated cost of \$500.00. A contract for the operation of this well is to be drawn up.

The Board requested the County Clerk to establish a file of all outstanding contracts and agreements showing the termination dates, and from this date on to advise the Board prior to the date of termination of any such contract or agreement.

BUDGET  
DISCUSSION

The Board met with representative members of the Douglas County Historical Society. Mr. Don Schaake, President, presented the planned objectives and estimated budget of the Society. The Board questioned the members concerning future plans for the coming years, possible historical emphases, ultimate location of the planned museum, etc. Because the submitted budgets for the two historical societies in Douglas County are larger than the funds allocated for this purpose for one year, the Board will consider the requests and make a decision before the 20th of March. The Board requested that the budget for 1969 of the Douglas County Historical Society be submitted by July 1, 1968.

The Board discussed the problem of office requirements in the Court House and particularly in reference to the Bindweed Supervisor and providing additional space for the County Treasurer.

The resolution authorizing the issuance of Bonds for Sub-District #2 of Main Sewer District #8 came up for hearing and determination. WATER WEED CUTTING  
MACHINE

The Board of County Commissioners has established a policy of making available to Douglas County residents a water weed cutting machine to be operated by County personnel on bodies of water of five (5) acres or more in which there are serious weed problems. Request for the use should be submitted to the Board and the machine and an operator will be furnished by the County.

The Board authorized the County Treasurer to pay interest in the amount of \$2,400 on temporary notes on Main Sewer District #10.
