ENUMERATION The Board discussed in great detail the enumeration check to be conducted in North Lawrence by the County Assessor. It was moved by Mr. Booth that the Assessor be instructed to make arrangements with Mr. Jesse Milan, Director of the Fairgrounds Community Day Camp, to use Day Camp Councilors of the age of 16 years or older to conduct the door-to-door enumeration. Seconded by Mr. Kampschroeder, motion carried.

The Board received a request from Schlup, Becker & Brennen, Consulting Engineers, making the study of the proposed New Kansas River Bridge, request asked for an extension of time for the completion of the study. Moved by Mr. Booth and seconded by Mr. Kampschroeder that because of additional studies needed, the extension of contract completion time should be granted. Motion carried.
