**TAX PROTEST** The Board received a personal property tax protest from the Alpha Kappa Lambda Building Association filed by Fred N. Six.

**LECOMPTON BRIDGE** The Boards of Douglas County and Jefferson County met with the Frisbie Bridge Company representation to sign the contracts for the Lecompton Bridge.

**lec. BR.** It was moved by Mr. Don Rice of Jefferson County and seconded by Mr. Harvey Booth of Douglas County that the recommended Alternate A type of structure be authorized for construction of the Lecompton Bridge. Motion carried unanimously.

**lec. BR.** It was moved by Mr. Kampschroeder of Douglas County and seconded by Mr. Floyd Petrie of Jefferson County that the contract be awarded to Frisbie Bridge Company of Topeka, Kansas for a sum of Seven Hundred seventy-one Thousand, Four hundred and eighteen dollars and twenty cents (\$771,418.20). Motion carried unanimously.

**lec. BR.** It was moved by Mr. Booth and seconded by Mr. Kampschroeder that in order to have the necessary funds to pay the Douglas County Share for the Lecompton Bridge construction, the County Attorney be instructed to prepare a resolution for the Board authorizing an application to be filed with the Kansas Highway Commission, requesting the loan of Four Hundred Thousand Dollars (\$400,00.00) as of January 1969, from the Highway Commission in a manner as set forth in Kansas Statutes 68-1138. Repayment to be scheduled starting 1970 at the rate of 2 mills per year from the special bridge levy.

The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board being present.

Approved the minutes of the meeting of June 24, 1968.

**VALLEYVIEW LEASE** It was moved by Mr. Kampschroeder and seconded by Mr. Booth that the Board enter into a lease with Willard E. Nice and Dorothy L. Nice, his wife, for the lease of the Valleyview Personal Care Home for a period of one year from this date.

The Board approved the payroll for the month of June. See proof of publication on file in the office of the County Clerk.

The Chairman signed a notice to Willow Springs Township Board that William Lee Randel has filed an application to sell Cereal Malt Beverage in Willow Springs Township.

**CO. VALUATION** The Board received from the County Clerk the 1968 County Valuation as of June 25, 1968 showing a total County valuation of \$104,152,820. Breakdown by cities and townships is on file.

**RESERVOIR SANITATION OFFICER** The Board received a letter from Mr. Ivan F. Shull, Chief of General Engineering and Sanitation Division of the Kansas State Department of Health pertaining to the appointment of Dr. Dale L. Clinton as County Reservoir sanitation Officer. Letter advised that the appointment was somewhat premature and they requested no appointment be made until after January 1, 1969.

It was moved by Mr. Booth and seconded by Mr. Kampschroeder that the appointment dated June 18, be rescinded and that no appointment for the position of County Reservoir Sanitation Officer be made until after January 1, 1969 and further that Dr. Clinton be advised.

**CITY STREETS & HIGHWAYS** The Board received a letter from the City Manager of the City of Lawrence requesting consideration on the part of the County Board for cooperation of construction of County Highway-City Street connecting links adjacent to the City of Lawrence. Considerable discussion was held between the Board and the County Engineer and a letter was sent to Mr. Wells requesting additional information on the connecting link on West 23rd. Street.

**VOCATIONAL TECH SCH.** The Board received notice from the Area Vocational/Technical School, Northeast Kansas Area, Topeka, Kansas, indicating anticipated enrollment of four Douglas County residents in the Vocational-Technical School for a possible total tuition cost of \$2,700. Letter was referred to Earl Wilson, Superintendent of Schools for his information.
