RESOLUTION NO. 130

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF DOUGLAS COUNTY, KANSAS, FIXING COSTS AND APPORTIONING COSTS OF THE IMPROVEMENT OF SUB-SEWER DISTRICT NO. 1, OF WAKARUSA MAIN BENEFIT SEWER DISTRICT NO. 10, DOUGLAS COUNTY, KANSAS.

Now on this 19th day of August, 1968, the Board of County Commissioners of Douglas County, Kansas, sitting as the Governing Body of Sub-sewer District No. 1, of Wakarusa Main Benefit Sewer District No. 10, Douglas County, Kansas, met in regular session in the Commissioners Room in the County Court House, in the City of Lawrence, Kansas, all members being present and participating, to-wit: Travis E. Glass, Chairman, Harvey Booth, Commissioner, and Walter Kampschroeder, Commissioner.

WHEREAS, the Board of County Commissioners has heretofore created Sub-sewer District No. 1, of Wakarusa Main Benefit Sewer District No. 10, Douglas County, Kansas, under and by authority of Kansas Statutes Annotated Section 19-2704a et seq., and Acts Amendatory or Supplemental thereto, which provide for the issuance of Bonds to pay for the costs of improvements; and

WHEREAS, on the 5th day of January, 1968, the contract for the construction of sewer improvements in Sub-sewer District No. 1, of Wakarusa Main Benefit Sewer District No. 10, was awarded for the improvements in said sub-sewer district, in the total amount of \$20,490.35, which bid was the lowest and best bid and within the estimate of \$34,000.00 allocated to said Sub-sewer District No. 1, of Wakarusa Main Benefit Sewer District No. 10, as set forth in Resolution No. 124; and

WHEREAS, the boundaries of Sub-sewer District No. 1, of Wakarusa Main Benefit Sewer District No. 10, served by the improvement aforesaid, have heretofore been determined and are hereby ratified and confirmed in all respects; and

WHEREAS, Black and Veatch, Consulting Engineers on said contract, report the completion of the same and there is on file with the County Clerk a final estimate of all construction costs in the sum of \$24,183.66 ; and

WHEREAS, Appraisers heretofore appointed by the Governing Body of Douglas County Sub-sewer District No. 1, of Wakarusa Main Benefit Sewer District No. 10, completed their report, on file with the County Clerk, and notice was published on the 24th day of February, 1968, setting the 11th day of March, 1968, as a date for all interested land owners to appear before the Board of Equalization, hearing any and all complaints of the valuations placed upon each tract and parcel of property as a basis for determining assessments on the same; and

WHEREAS, following the hearing aforesaid, the Appraisers' Report was confirmed and the total costs of the project in the amount of \$ 31,019.88 was ordered assessed over a twenty year period as provided by law, on the basis of the appraisals made . against the property benefited by the improvements heretofore authorized and now completed.
