The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board being present.

Approved the minutes of the meeting of September 23, 1968.

*TAX SALE* The Board discussed with the County Attorney the judicial tax sale. The County Attorney was instructed to proceed at once with the plan of obtaining judgment during the year 1968, and to take whatever steps are necessary to prepare the petition, either with Mr. Klooz or any other party that he would need to contract with in order to meet the deadline.

*Juvenile Officer* It was moved by Mr. Booth and seconded by Mr. Kampschroeder that the salary scale for the position of Juvenile Officer be established as of October 1, 1968. The starting salary shall be \$300.00 per month with a maximum of \$450.00 per month. The applicable wage shall be approved by the Board of County Commissioners upon the recommendation from the Probate Judge and based upon the qualification, experience, and educational background of the Juvenile Officer. Motion carried unanimously.

It was moved by Mr. Booth and seconded by Mr. Kampschroeder that the salary of Carol Mesigh, Juvenile Officer be increased to \$435.00 per month, effective October 1, 1968. Motion carried unanimously.

The Board authorized the Sheriff to purchase a new electric dryer for use in the jail at a cost of \$160.00.

No further business, the Board adjourned to meet on September 27, 1968.

*Planning Comm.* The Board received the minutes of the Douglas County Planning Meeting of September 26, 1968. It was moved by Mr. Booth and seconded by Mr. Kampschroeder that the minutes be approved and the conditional use permit be granted subject to the plans as submitted by the applicant and on file with the County Zoning Administrator for the establishment of an airport in Vinland. Motion carried unanimously.

*Employee* It was moved by Mr. Kampschroeder and seconded by Mr. Glass that the County Engineer be authorized to hire Mrs. Betty Leib as clerk to replace Mrs. Janice McConnell at a starting salary of \$280.00 per month effective September 11, 1968. Mrs. Leib will also receive a salary of \$10.00 per month from the Zoning Office, the Weed Department, and the Park Department. Motion carried unanimously.

*Community Action* The Board received a request from Mr. William A. Binns, Chairman of the Community Resources Board, Douglas County, Kansas, requesting the Board of County Commissioners to designate the Eastern Central Kansas Community Action Program, the agency for Community Action Programs of the Office of Economic Opportunity. It was moved by Mr. Kampschroeder and seconded by Mr. Glass that the date and time of October 16, 1968 at 10:30 a.m. will be the time for hearing by the Douglas County Board of County Commissioners on the question of designating an agency for Community Action Programs in Douglas County. Motion carried.

No further business, the Board adjourned to meet September 30, 1968.

*SALE OF PROPERTY* It was moved by Mr. Kampschroeder and seconded by Mr. Booth that the County Clerk be instructed to place a classified ad concerning the sale of the houses east of the jail for one week prior to the sale date in the Lawrence Daily Journal World, and the Monday and Friday editions prior to the sale date in the Outlook, the Wednesday prior to sale date in the Baldwin Ledger, for one week prior to the sale on KILWN, and further that a two column by three inch display ad be published in the Lawrence Daily Journal World on Monday, October 14, in addition to the classified ads. Motion carried unanimously.

It was moved by Mr. Booth and seconded by Mr. Kampschroeder that Hays Brothers Auctioneers be engaged as the firm to conduct the sale for houses to be moved, sale to be held October 16, 1968. The fee for services of Hays Brothers Auctioneers shall be 5% of the gross amount of the sale with a \$50.00 minimum. Ads and miscellaneous expense of the sale to be paid by Douglas County. Motion carried unanimously.
