DECLINE METRO PLAN COMM It was moved by Mr. Booth and seconded by Mr. Kampschroeder that at the present time Douglas County will not ask to be included in the Metropolitan Planning Commission - Kansas City Region and that the Board so advise the director of the Metropolitan Planning Commission.

It was moved by Mr. Booth and seconded by Mr. Kampschroeder that the Board send a letter to the Shawnee County Commission advising them of the Board's action concerning the Metropolitan Planning Commission, and expressing an interest in possible future cooperation between Shawnee and Douglas County in the area of Planning.

EMPLOYMENT The Board authorized the County Treasurer to employ Nancy Johnson at a starting salary of \$275.00 per month to replace Hulda Alber who is retiring.
