Bridge: East 11th

The Board made an inspection trip to a County Bridge on East 11th. Street after it becomes the Wakarusa Township Road. After viewing the bridge, the Board recommended that a sample be taken of the discharge water from the CO-OP Plant to determine if the water would be detrimental to a concrete or metal pipe. It was the recommendation of the Board that the existing structure be replaced with an adequate size bituminous coated metal pipe.

The County Appraiser, John Clyatt, appeared before the Board to request a polaroid camera for the purpose of photographing houses to clarify their classification with the County Assessor. Request denied.

Employee

Sheriff Rex Johnson requested permission to hire a temporary part-time employee to compile some statistical information on prisoners in the Douglas County jail for the past year. Permission granted by the Board.

The Board met with the Welfare Director, John Derrick.

Assessors Office*

The Board received two bids for supplies for the County Assessor. It was moved by Mr. Booth and seconded by Mr. Kampshroeder that the low bid of the Allen Press of Lawrence, Kansas, to supply the necessary forms as requested in list #1 be accepted in the amount of \$576.80 and that the County Assessor be authorized to notify Allen Press to supply the necessary forms.

Effective December 1, 1968, Fred Nightingale and Harold Wilburn will work a 44 hour week.

The County Engineer appeared before the Board and discussed speed limits on County Roads. Decision was delayed until an opinion could be obtained from the County Attorney concerning County liability.

It was moved by Mr. Booth and seconded by Mr. Kampshroeder that the Board authorize the County Engineer to proceed to prepare specifications and secure bids on two pick-up trucks and two 2-Ton Cabs and Chassis. Motion carried unanimously.

Commissioners Cancellation Orders #591 and #592 were approved by the Board and signed by the Chairman. Orders are on file in the office of the County Clerk.

Mr. Alvin Row, architect, appeared before the Board to discuss the proposed new building at the 4-H Fairgrounds. No decision was reached and Mr. Row was asked to return on Monday, December 2, 1968.
