Lecompton Township

It was moved by Mr. Kampschroeder and seconded by Mr. Booth that James R. Banks of Rt. 1; Lecompton, Kansas, be appointed to fill the vacancy for the unexpired term as treasurer of the Lecompton Township Board. Motion carried unanimously.

HIRE ARCHITECT

It was moved by Mr. Kampschroeder and seconded by Mr. Glass that Mr. Alvin Row, architect, be engaged to prepare working drawings and specifications for a 70 foot by 80 foot building to be constructed at the 4-H Fairgrounds for the total fee of \$2,600 of which a sum of \$1,000.00 has been paid. The extent of the services to supervise the construction of the building up to the completion date of August 1, 1969. Mr. Kampschroeder and Mr. Glass voted in favor. Mr. Booth voted against.

ZONING

It was moved by Mr. Booth and seconded by Mr. Kampschroeder that the County Zoning Administrator be instructed to take immediate steps to enforce all provisions of the County Zoning Ordinance and to submit to the County Attorney a complaint of violations of the Zoning Ordinance and request from the County Attorney that immediate action be taken upon the direction of the Board of County Commissioners. Motion carried unanimously.

No further business, the Board adjourned to meet on December 9, 1968.

The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board being present.

The Board discussed overtime with the Courthouse Maintenance Overseer, Harold Wilburn. He was instructed to keep a record of his hours overtime and turn them into the Board at the end of each month.

INDUSTRIAL PARK

It was moved by Mr. Glass and seconded by Mr. Booth that the County Engineer be instructed to put in a new 40 foot approach at the south entrance to the Industrial Park on Haskell Avenue south of 23rd. Street. Motion carried unanimously.

BROKEN ARROW PARK

SKATING The Board discussed parking area at Broken Arrow Park for use in conjunction with the proposed skating rink. It was moved by Mr. Booth and seconded by Mr. Kampschroeder that the Board instruct the County Engineer to put an entrance from the East and West road into the township facility at a point along the fill that the County made with dirt last spring and that the total fill area be bladed down for the capability of applying rock cover. Motion carried unanimously.

EMPLOY PURVIS

It was moved by Mr. Kampschrieder and seconded by Mr. Booth that the Board extend an offer of employment to Mr. Fred Purvis of Bladwin, Kansas, to serve in the capacity of County Maintenance Supervisor at a rate of \$500.00 per month with a vehicle to be furnished effective the forepart of the year 1969. Motion carried unanimously.

No further business, the Board adjourned to meet December 11, 1968.

The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board being present.

Approved the minutes of the meeting of December 9, 1968, and of the meeting of December 6, 1968.

Commissioners Cancellation Orders #597, 598 and 599, and 600 were approved by the Board and signed by the Chairman. Orders are on file in the office of the County Clerk.

ROAD MULCHING

SHOULDERS It was moved by Mr. Kampschroeder and seconded by Mr. Booth that the proposals of the Yard and Garden Company for furnishing labor and equipment and materials except brome seed to seed and mulch shoulder and right-of-way for FAS Project 23S-1283(2) at a total price of \$2,925.00. County Engineer is instructed to negotiate with Mr. Don Grob of the Yard and Garden Company for a change from a straw mulch material to a hay mulch at a price differential not to exceed 25¢ a bale for the material used. Motion carried unanimously.

TAX PROTEST

The Board received a copy of the real property and personal property tax protest statement from Alpha Kappa Lambda Building Association. Statement was referred to the County Attorney.

IDLE FUNDS

It was moved by Mr. Kampschroeder and seconded by Mr. Booth that the Board instruct the County Treasurer to proceed with the investment of Idle Funds in a manner as prescribed by Chapter 217 of the 1968 Session Laws of Kansas. The opportunity to accept these investments shall be extended to all six banks located within Douglas County in a ratio as determined from the total assets of each respective bank as of June 30, 1968. The ratio shall be redetermined annually on November 1 of each year based on the current schedule of total assets as reported by the respective banks on June 30 of each year. Motion carried unanimously.

NOISE: PUMPING STATION

Mr. Ralph King, attorney, and Mr. John Clyatt, County Zoning Administrator appeared in response to hearing set for 10:00 a.m. pertaining to the operation of a pumping station east of Stull adjacent to the Jim O'Connor Farm. Mr. King advised that the owner of the pumping station had taken steps to minimize the noise problem and at the present time, he wishes to withdraw his complaint.
