The Board received Summons' in Case #25146, Sigma Alpha Epsilon Fraternal Assoc., A corporatio and in Case #25147, Alpha Kappa Lambda Building Assoc., A Corporation. These summons' were referred to the County Attorney. The Board received the quarterly report of Stenographer Fees from the Clerk of the District Court. The report was approved by the Board. Commissioners Cancellation Orders #612 and #613 were approved by the Board and signed by the Chairmna. Orders are on file in the office of the County Clerk. The Board approved the advertisement to be placed in the Kansas Governmental Journal and the Kansas Professional Engineering Magazine advertising for an Assistant County Engineer. Jac Bids It was moved by Mr. Kampschroeder that the bids for Gasoline and Diesel Fuel for one year for the Road and Bridge Department and Sheriff's Office be received at 10:00 a.m., Monday, January 27, 1969.
