WHEREAS, as for County Officials, or their designated employee, attending state conventions or meetings on official business, said person shall be allowed transportation costs, lodging, registration fee and meals, meal allowance not to exceed \$6.00 per day; on meetings of one day or less, the allowance shall be registration fee, mileage and one meal not to exceed \$2.00. The Board of County Commissioners may approve time off and reimbursement of expenses, for only one representative at a time, from any one office. Payment of said expenses shall be made upon presentation of receipted bills upon their return.
