The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board being present.

Approved the minutes of the meeting of May 5, 1969.

The Board ordered the reinvestment of \$50,000 from the special building and equipment fund for a 90 day period.

The Board received notice relating to the hearing on the Vacation of Ranchero Valley West. One copy to be forwarded to the City Commission and a copy to the City Planning Commission.

Extension Budget
It was moved by Mr. Heck and seconded by Mr. Ice that the proposed budget of \$65,382 from the Douglas County Extension Service for the year 1970 be approved as being the one without providing for the hiring of a horticulturist. Motion carried unanimously.

The Board received notice relating to the hearing on the Vacation of Ranchero Valley West. One copy to be forwarded to the City Commission and a copy to the City Planning Commission.

Fund Balance
The Board received the quarterly statement of fund balances from the County Treasurer for the quarter ending April 30, 1969.

Petition to annex territory to Cemetery Dist
The matter of petition for annexation by the United Cemetery District as received by the Board on May 5, 1969 was reviewed. A certificate from the County Clerk certifying the accuracy of the enumeration of the district and the listing of the qualified electors of the district having been received, it was moved by Mr. Heck that an order be issued by the Board granting the petition to annex territory into the said United Cemetery District of Douglas and Franklin Counties. Motion was seconded by Mr. Ice and carried unanimously.

Hildebrand Drainage Problem
Mr. Hildebrand appeared before the Board to call to the Board's attention a drainage problem in his field, $\frac{1}{4}$ mile east of Stull on the Kansas Stull Road and the County Engineer will be instructed to inspect and report back to the Board his findings.

No further business, the Board adjourned to meet on May 9, 1969.
