A discussion was held concerning the status of the existing contract with Schlup, Becker and Brennan and a request for directions from the Board as to how the firm should complete their contract and study was made. After considerable discussion, Mr. Schlup was advised to submit a proposal to the Board for any necessary changes in their contract brought about by possible cost increases caused by the delay in completing a final design for a four (4) lane structure with a southern terminus at 6th. and Tennessee and on grade intersections at the North and South entrances to the Bridge.

The Board received a request from Harvey Booth and Arden Booth for consideration of limited access east-west truck highway south of Lawrence and for a solution to the waterway problem to provide drainage from the City of Lawrence to the major streams.
