The Board met with Commissioners Ice and Glass present. Commissioner Heck was absent due to the death of his brother Walter.

The Board met with Bob Steele, caretaker of Lone Star Lake, and discussed the activities and problems at the Lake.

Overtime granted for Sheriff's men

Sheriff Johnson appeared before the Board to discuss overtime pay for Deputy Sheriff's for extra work occasioned by unusual activities or sporting events. It was moved by Mr. Ice that an overtime rate of \$2.50 per hour be established for County Sheriff's Officers, overtime as of this date. Motion was seconded by Mr. Glass and carried.

The County Engineer reported to the Board on the work in progress by the County Road and Bridge Department.

Revised plat of Rancho Verde

Mr. Fred Six, attorney representing Mr. Rees Jackman, presented a revised preliminary plat of Rancho Verde Estates, in Section 21-13-19, Douglas County, Kansas. Mr. Ron Short, Lawrence-Douglas County Planner, John Clyatt, Douglas County Zoning Administrator were present as well as Mrs. Lichwart representing the Beautification Council.

Mr. Short presented to the Board his views and opinions concerning the proposed plat. He called to the attention of the Board the restrictions as imposed by this Board in their letter of July 9, 1969, to Mr. Jackman. Mr. Short asked for clarification of the requirements before the plat be accepted, also questioned whether the revised proposed plat should not be presented to the City-County Planning Board for their recommendations prior to being considered by the Board of County Commissioners. No action taken, matter was deferred until 10 a.m., Monday, September 8, 1969, pending an opinion from the County Attorney.

Mr. Bob Neis, Civil Defense Director of Eudora, Mr. Bob Hellstrom, Douglas County Civil Defense Director and Sheriff Johnson appeared before the Board to discuss the advisability of purchasing additional radio equipment on the Governmental Band for use in the City of Eudora. Such unit to be primarily for use in times of severe weather by the Civil Defense personnel. Matter was taken under advisement by the Board pending a report from the Sheriff on the license requirements of the Governmental Band.

No further business, the Board adjourned to meet September 5, 1969.
