It was moved by Mr. Heck and seconded by Mr. Ice that Mr. Steele be instructed to post signs around the lake prohibiting the removal of Walleye Pike from Lone Star Lake prior to March 1, 1972. Motion carried unanimously.

Sanitary Landfill in Eudora

Mr. Dale Swisher discussed with the Board his application for a permit to construct and operate a sanitary landfill in Eudora. After reviewing the recommendations of the planning commission concerning this request, the Board delayed final action until they could confirm with the local health Board the necessity of approval by the State Health Board.

Rancho Verde Estate Plat

Mr. Ron Short, Planning Director, Mr. John Clyatt, Zoning Administrator, Mr. Rees Jackman, applicant for plat of Rancho Verde Estates, and Mr. Fred Six, attorney for Mr. Jackman, appeared before the Board to discuss the final approval of the proposed Rancho Verde Estates Plat. The four recommendations of the Planning Commission as stipulated in their meeting of September 17, 1969, were thoroughly discussed by the Board. Recommendations #1, 2, and 4 were selected to be imposed by the Board, but due to the Opinion #69-22 from the County Attorney, recommendation #3 will be deleted.
