Crushed rock*

It was moved by Mr. Ice and seconded by Mr. Heck that the Board enter into a contract with Martin Marietta Corporation of Topeka, Kansas for 15,000 tons of SS-3 crushed rock at \$1.30 per ton at the quarry located in the SW $\frac{1}{4}$ of Section 4, Township 13, Range 19E in Douglas County. The Board also instructed the County Engineer to see that the stock piles set aside for Douglas County be properly marked and identified as such. Motion carried unanimously.

for condemned
land & New York
State v. Robert Johnson*

It was moved by Mr. Ice and seconded by Mr. Heck that the Board approve Resolution #69-16. authorizing the payment to the Clerk of the District Court the sum of \$248,890.35, the same being the amount of the condemnation awards and court costs. Additionally, the resolution authorized the payment of \$5,071.21 in attorneys' fees. All expenditures are for payment of land obtained under the right of eminent domain in Case #25533 in the District Court of Douglas County, Kansas. Also, said resolution provides for the issuance of a no fund warrant to the Douglas County State Bank of Lawrence, Kansas, in the amount of \$14,200, to provide the additional funds needed between the present cash balance on hand in the special building and equipment fund and the amount required for the total payment to the Clerk of the District Court and attorneys' fees. Motion carried unanimously.
