The Board of County Commissioners met in regular adjourned session with all members of the Board being present.

Approved the minutes of the meeting of December 3, 1969

Comm. Order #671, 672, 673 Commissioners Cancellation Orders #671, 672, 673 were approved by the Board and signed by the Chairman. Orders are on file in the office of the County Clerk.

increase in wage for Leroy Knight It was moved by Mr. Heck and seconded by Mr. Ice that Leroy Knight be granted a six months increment raise of \$20.00 as of the first of January. Motion carried unanimously.

Change Order #1 for Lecompton Bridge The Board was presented a supplemental agreement Change Order #1 to a contract between the Board of County Commissioners of Douglas County and Jefferson County, Kansas, party of the first part, and Frisbe Bridge Company, Inc. party of the second part, in a contract designated as Lecompton Bridge over Kansas River, Bridge contract dated June 24, 1968. The change order to provide for estimate payments to the contractor for all acceptable structural steel delivered to the project and properly stored. It was moved by Mr. Heck and seconded by Mr. Ice that the Change Order #1 be approved. Motion carried unanimously.

purchase tires for weed Dept. It was moved by Mr. Ice and seconded by Mr. Heck that the Bindweed Supervisor be authorized to purchase 4 new tires for the bindweed department truck from Fritz Company of Lawrence, Kansas. Total consideration to be \$157.79. Motion carried unanimously.

Resolution closing part of Road #7-A It was moved by Mr. Heck and seconded by Mr. Ice that the Board adopt Resolution #69-17 closing a part of Road #7-A in Douglas County, Kansas, in accordance with the statutes in the State of Kansas. The Road is described as beginning at a point on the center line of Road No. 7-A (Territorial Road) and 30 feet West of the East line of Section 12, Township 15, South, Range 20 East, in Douglas County, Kansas. Thence N89° 12'W to a point 57.48 chains West of the West line of vacated town of Blackjack, thence S45°42'W 31.16 chains to the center of said Section 12, thence S87°20'W 38.98 chains to a point 20 feet East of the Quarter Section corner on the West line of said Section 12, and terminating at said point. Motion carried unanimously.

Sheriff purchase Radar It was moved by Mr. Heck and seconded by Mr. Ice that the Sheriff be authorized to purchase a Stephenson Mark 6 Radar from Law Enforcement Equipment Company, Kansas City, Missouri, at a bid price of \$1,215.00. Immediate delivery is available on the machine. Motion carried unanimously.
