Engineering agreement  
with Van Doren,  
Hazard, Stallings &  
Schnacke for new  
road from U.S. 59  
to Haskell Avenue

The Engineer presented to the Board a proposed agreement for engineering service by the Engineering Firm of Van Doren, Hazard, Stallings, & Schnacke of Topeka, Kansas, proposing to furnish engineering services including necessary surveys and preliminary plans, final design plans, specifications, and cost estimates, and construction phase services, if desired, for a proposed road to be generally located along the South line of Section 12, Township 13, Range 19, & Section 7, Township 13, Range 20 from U.S. Highway 59 east to Haskell Avenue. Proposed road generally bordering the South edge of Broken Arrow Park. Phase 1 consisting of the surveys and preliminary plans to be provided for the sum of \$12,000.00. Phase 2 consisting of final design plans and specifications, and cost estimates, if requested, for the sum of \$15,000.00. Phase 3 consisting of the construction phase services, if requested, shall be made on a per diem charge for the men involved and necessary transportation. Phase 1 to be completed within a period of 60 calendar days. Phase 2 to be completed within a period of 75 calendar days after completion of Phase 1. It was moved by Mr. Heck and seconded by Mr. Ice that the agreement be so executed. Motion carried unanimously.
