When the resolution is prepared, it shall be presented to the Board for adoption and publication and it will not be effective until publication. dissolve agreement with Mr. Harold Skinner

The Board received a request for cancellation of an agreement made March 11, 1970, between the Board of County Commissioners and Mr. Harold Skinner, Route 2, the agreement being for the purchase of Tract #14 of the properties sold at public auction by the Board on March 11, in the area between New Hampshire and Rhode Island and 11th. and 12th. Streets, which area is being cleared by the Board for use as a proposed building site. The request for cancellation of the agreement was brought about due to the death of Mr. Skinner, it being impossible for the remaining family to comply with terms of the agreement. After consideration of the request, it was moved by Mr. Ice and seconded by Mr. Heck that the agreement be cancelled as of this date, the County Clerk be authorized and instructed to return the deposit in the amount of \$250.00 and the purchase price amount of \$14.00. Such refund is to be made to Mrs. Harold Skinner. Motion carried unanimously.
