public hearing on planning board minutes: Item #1 mobile home park (Webster & Hill)

The Board conducted a public hearing on Item #11 of the Planning Board Minutes of May 13, 1970, concerning a request for a conditional use permit for a mobile home park in the S $\frac{1}{2}$ of the NE $\frac{1}{4}$ of Section 14, Township 13S, Range 19E. After discussion, the following motion was made. Subject to the following three conditions:

- #1 that this Board approve the drainage improvements prior to the issuance of the conditional use permit,
- #2 enforce a no left turn regulation at the Northeast corner of the request in question,
- #3 that the Board strongly recommend that the East 15 acres of this tract be in the future only for residential purposes of some sort,

It was moved by Mr. Heck that a conditional use permit for the mobile home park be approved. Motion was seconded by Mr. Ice and carried unanimously.
