In furtherance of the construction of Douglas County road #698 the Board reviewed the agreement of April 1, 1970, as submitted by Finney & Turnipseed, Consulting Engineers, Topeka, Kans., and their proposal for construction phase engineering services on the project. After consideration, it was moved by Mr. Ice that the firm of Finney & Turnipseed be engaged to engineer and supervise the construction phase at hourly rates as stipulated in paragraph 13 of Article 3, of the Agreement with a maximum cost for the services not to exceed \$11,500. Seconded by Mr. Heck and carried unanimously.

Cropp, Guidance Chairman, Lawrence High School; all letters referring to the same problem. Board received from Mrs. Cook an offer of assistance from numerous community organizations to study and to make recommendations for correcting the deficiency in the County. The offer was taken under advisement pending further information to be furnished by Mrs. Cook relative to possible Federal funding assistance on such a program to create adequate detention facilities.
