Pursuant to discussions of a proposed change by the owner of Mobile Acres So., Inc. relative to the treatment of the North border of the development, the Board met with owner Mr. Bill Webster, and the owners of adjacent property, Mr. Steve Sublett, Mr. Charles Bratton and Mrs. L. T. Merrifield at the site on Saturday morning, April 24th. The discussion which ensued resulted in an agreement that in lieu of a six ft. high board fence as previously set out, that the owners of Mobile Acres South would implement the following:

1. That the South ditch of the East-West Road joining Mobile Acres South will be filled in such a manner that run-off water from the road flows directly to the slope of the drainage-way constructed on property of Mobile Homes South.

2. That owners of Mobile Homes South will construct a six ft. high chainlink fence approximately 25 ft. South of the North property line running from the Mobile Acres South, North-South entrance road, to a point in line with the West property line of Nieder Acres.

3. The owners of Mobile Homes South will properly plant a professionally recommended variety of screening shrub on the immediate North side of this fence, and will in addition make some plantings of other trees and evergreens North of this shrubery.

4. Owners of Mobile Acres South will seed the setback area and maintain shrubbery and grass area in an attractive manner.
