Percival's*

Mr. and Mrs. M. R. Percival, who live south and west of Eudora and in Eudora Twp., appeared before the Board and brought to the Board's attention that they did not agree with the County survey establishing a road of record on the west side of their property. It is the understanding of this Board that this survey was requested by the Eudora Twp. Board so that if they so desired, they might grade and maintain this roadway. Present for the discussion were County Counselor Dan Young, Engineers Sanderson and Rice and Surveyor Tommy McGee. All county officials present were in general agreement with the statement to Mr. and Mrs. Percival by the Commission Chairman that county road records showed this road as surveyed by the County Surveyor to be a dedicated road described as presently surveyed, and since there is no record of this road being vacated the road remains a dedicated roadway.

sub-divisions  
adopted*

Ass't County Engineer Sanderson presented Board revised and upgraded road requirements for sub-divisions located outside the proposed primary growth area of Douglas County. The proposed primary growth area referred to is as contemplated by the City-County Planning staff as of this date. These requirements will supercede those adopted Feb. 4, 1970. The new regulations differ in that graded roadway is standardized at 27 foot width, shoulder slope is changed from 2 to 1, to 3 to 1, and ditch depth is increased from 1½ ft. to 2 ft. Road surface standards will require a rolled stone base 27 ft. wide and 6" thick of AB-3 material, liquid asphalt for prime MC-30 at rate of .25 gal. per sq. yd., first seal; liquid asphalt RC-800 at .3 gal. per sq. yd. 27 ft. wide. Cover material shall be CM-8 at 26 lbs. per sq. yd. It was moved by Mr. Cragan, seconded by Mr. Ice that these regulations be adopted as of this date. Motion carried unanimously. These standards are on file in the office of the County Engineer.

Board approved cereal malt beverage license for Jerry's Tavern, Route #1, Baldwin, Kansas, in Willow Springs Twp. The license is issued to Mr. Jerry A. Craig.

Board considered a proposal from Mr. Carl Faulk for erecting and installing equipment for lighting the ball diamond at the 4-H Fairgrounds. Mr. Faulk agrees to contract this installation of County furnished materials at a cost not to exceed \$1850.00. It was moved by Mr. Cragan, seconded by Mr. Ice that the proposal of Mr. Faulk be accepted. Motion carried unanimously. Copy of the contract is on file. Board will carry county protecting liability insurance on this project, and requested our insurer to supply such insurance. It is understood that such policy is to cost approximately \$40.00.
