After considerable discussion and after indications by the Board to provide funds for Cottonwood, Inc., it was agreed to proceed with the necessary publication that this Board intended to levy not to exceed .2 mill of the statutory .5 limit allowed for mental retardation by Statute 19-4001.

As a result of previous discussion relative to the need of part-time secretarial help in his office, Wayne Kellum, Co. Zoning Administrator, appeared before the Board to request permission to employ on a one-half time basis Miss Teresa Hodson. The position would be that of Clerk-typist and the requested salary was \$150.00 per month effective August 1st. Mr. Kellum related to the Board that in addition to the duties required by his office that Miss Hodson would be available for extra duties as might be required by either the office of the County Commissioners or the County Engineer's office. It was moved by Mr. Ice, seconded by Mr. Cragan that Mr. Kellum's request be granted. Motion carried unanimously.

Wayne Bly, Director of the Lawrence Recreation Dept., appeared before the Board to advise the Board of the need of lighting in the playground area in the County portion of Broken Arrow Park. After considerable discussion it was agreed to request Mr. Bly to contact Kans. Power & Light Co. and ask for 2 Company owned space lights to be installed in the Douglas Co. section of Broken Arrow Park at points designated by Mr. Bly.

Commissioners Cancellation Order #897 was approved by the Board and signed by the Chairman. Order is on file in the office of the County Clerk.

*Xerox to install
machines:

Mr. Harry Chabin, representing the Xerox Corp., appeared before the Board to further discuss the proposal presented to the Board previously. After due discussion it was moved by Mr. Ice, seconded by Mr. Cragan that we accept the proposal presented by Mr. Chabin, and ask him to proceed to install in the office of the County Clerk on the first floor of the courthouse a Xerox 720 machine and to install in the office of the Clerk of the Dist. Court a Xerox 660 machine, and also in the Co. Engr's office in the basement of the courthouse a Xerox 660 machine. Motion carried unanimously. The proposal sets out a monthly rental charge on a Xerox 720 of \$175. per month and on the Xerox 660 machines \$60. each per month, or a total monthly charge of \$295.00. This monthly rental allows a total of 9800 copies per month without an additional charge. Mr. Chabin will prepare a contract for review.

Mr. Delbert Mathia appeared before the Board to inform the Board of a Statute passed by the 1970 legislature which allows that any person on leave from active duty from the Armed Services is allowed State hunting and fishing privileges without permits or licenses, applying to Kansas residents only. Mr. Mathia recommended to the Board that relative to county hunting and fishing permits that Douglas Co. concur with this State Legislation. It was moved by Mr. Ice, seconded by Mr. Cragan and carried unanimously that Douglas Co. concur
