The Board of County Commissioners of Douglas County met in regular adjourned session with two members of the Board present. Mr. Walter Cragan was absent.

Approved the minutes of the meeting of August 9, 1971.

*Employ: Blenda Sue Coachman*

Mrs. McMinn appeared before the Board representing the Probate Court, to request permission to employ as a Clerk Typist in that office Mrs. Brenda Sue Coachman at a starting salary of \$300. per month beginning August 12th. It was moved by Mr. Ice, seconded by Mr. Heck that this request be granted. Carried unanimously.

*Proposal for lighting Broken Arrow Park accepted*

Representatives of the Recreation Dept. appeared before the Board to further discuss the need for lighting in the play area of the County section of Broken Arrow Park. A proposal was presented to the Board from the Kans., Power & Light Company for the installation of 3 space lights at a cost of \$24.15 per month. The Board gave due consideration to additional use of the area and to improved security which would be provided with proper lighting. It was moved by Mr. Ice, seconded by Mr. Heck and carried unanimously that the proposal be accepted.

*Fund balances*

Board noted receipt from the Co. Treasurer of a statement of fund balances, both totally and broken down of the governmental subdivisions as of the quarter ending July 31, 1971.

*3-M Copier available to Douglas Co. Health Dept.*

The Board referred to the minutes on July 30th, at which time the Board made the decision that because of an indication by the Extension Service that they would like the use of the County owned 3-M 203 copying machine, that the machine would be made available to that office. However after inspecting the machine the Extension Dept. found that inasmuch as the machine did not produce their most needed copy, namely transparent copies, that they should decline use of the machine. The Douglas County Health Dept. was then notified that the copying machine was available if they had use for same. The Health Dept. has advised the Board that they would make use of the copier, and it was moved by Mr. Ice, seconded by Mr. Heck and carried unanimously that the copier be made available to the Douglas Co. Health Dept. The machine remains the property of Douglas County.

*Memo from Kans. Salvage Board re. Solid Waste*

A Memo from the Kansas Salvage Board was received directed to all Municipalities and Governing Bodies of Counties in Kansas, notifying same that all Municipal Corporations and Governing Bodies who maintain garbage dumps, sanitary landfills, refuse dumps, etc. within 1,000 ft. of any public road are subject to the Salvage Law and licensing thereunder on a no fee charge basis. The Board knows of no instance where Douglas County would be involved and in need of such a license.

*Hamm Const. Co. low bidder, 31st Street project*

At 10:00 a.m. the Board meeting moved to the Douglas County Courtroom where bids were received for the construction of Douglas County, Kansas, Road #699 or 31st Street. Twelve bids were received. The apparent low bidder on the project was the Hamm Construction Co. of Perry, Kansas, with a bid of \$157,572.22. All extensions and factors relating to the bid will be checked and verified by the Consulting Engineers and the County Engineer's office prior to the final award being made.

*Engr. Ice, Bonds rec'd warrants from County*

Board noted receipt from the Engineer of Secondary Roads of a letter of acknowledgment that they have received County Warrant #1390 covering deficit on contract 23 S 1527; also acknowledging receipt of Warrant #1423 in the amount of \$64,981.36 covering the fourth and final payment on the Lecompton Bridge.
