The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board present.

Approved the minutes of the meeting of September 17, 1971.

Engineer Sanderson appeared before the Board with quotes from suppliers on three snow plow units to be used on trucks recently purchased. After reviewing the quotations it became apparent that the two best bids were for a Valk #RV 101-60-30" plow, which was quoted by 2 suppliers, namely the C. Ted Wolf Company of Lindsborg, Kansas, and Wentz Equipment Company of Topeka. After due consideration it was moved by Mr. Ice, seconded by Mr. Cragan that we accept the lowest quotation which was from the Wentz Equipment Company, for three of the previously described units at a net cost of \$3,035.00, which price reflects allowance for trade in of two terracing machines in the amount of \$218.50. For a price differential of \$160.00 per unit carbide tipped cutting-edge blades shall be furnished for a total additional cost of \$480.00. At a per unit price of \$70.00, caster wheels in lieu of shoes shall be furnished for a total cost of \$210.00. These added features bring the total net cost of the three units to \$3,725.00. Motion carried unanimously.

Property Supervisor, Al Skeet, appeared before the Board to request authority to employ Robert BeeBe on a part-time basis at \$2.15 per hour, effective September 14th. It was moved by Mr. Cragan, seconded by Mr. Ice that this request be granted, with the understanding that Mr. BeeBe be employed on a part-time basis until December 1, 1971, at which time the status of his employment will be reviewed.

No further business, the Board adjourned to meet on Wednesday, Sept. 22, 1971.
