Janice Beem, Register of Deeds, appeared before the Board to explain that the recording equipment in her office has reached a point of requiring major repair. Mrs. Beem discussed with the Board the possibilities of installing new recording equipment, either on a purchase or lease basis. Mrs. Beem indicated that there are 2 systems in general use. One of these systems is a card system recorder, the other largely microfilm operation. The Board requested Mrs. Beem to make every effort to determine all the facts pertinent to these 2 systems by visiting other offices where these systems are in operation and if possible to bring recommendations to this Board relative to the 2 types of equipment and also relative to purchase and rental costs of the two systems.

Civil Defense Dir. Belote appeared before the Board with the information that various sized emergency generators were available on loan from the office of Civil Defense. Mr. Belote indicated that he felt by all means at this time we should replace the 20 k.w. generator which we now have with a 40 k.w. and request an additional 5 k.w. portable unit. It was moved by Mr. Ice, seconded by Mr. Cragan that we authorize Mr. Belote to request these 2 units with the understanding that he will inspect the 2 units and will process the application only if he finds the equipment to be in good condition. Motion carried unanimously. Mr. Belote further requested authority to purchase identification insignia to be placed on uniforms of Civil Defense emergency volunteer unit. It was moved by Mr. Cragan, seconded by Mr. Ice that permission be granted to purchase this identification. Motion carried unanimously.
