Bar Association appeared before the Board to request the use of the Douglas County Courtroom for a meeting of the bar association on Tuesday, March 14, at 7:30 p.m. for the purpose of discussing public defender program. After due discussion it was moved by Mr. Ice and seconded by Mr. Cragan that this request be granted. Motion carried unanimously.

*Zoning: Request
to rezone .69 acres
from A to B-1
on East 23rd St.*

Mr. McClanathan, joint city-county planning commission, and Wayne Kellum, County Zoning Administrator, appeared before the Board to present item Z-12-37-71 of the minutes of the February 23 meeting of the joint planning commission. This item being a request to rezone approximately .69 acres from A (Agricultural) to B-1 (Neighborhood Business). This request was submitted by Rev. Leslie King of the Faith Assembly of God Church. The item was presented by Mr. McClanathan and Rev. King spoke in support of the request and Mr. Don Arick brought to the attention of the Board that care should be taken in granting the use of septic fields in that particular area. Inasmuch as this case involves a zoning district line splitting the property and inasmuch as there already exists a frontage road at this location and with the understanding that granting this request is not to be construed as a precedent for granting other rezoning along 23rd Street. It was moved by Mr. Cragan and seconded by Mr. Ice that the recommendation of the joint planning commission be accepted which was that the aforementioned request be approved. Motion carried unanimously. This rezoning to become effective upon proper official publication.

Assessor Rogers appeared before the Board to request a one year length of service salary increase for Mrs. Ruth Vervynck of \$20 per month which would make Mrs. Vervynck's salary \$405 per month effective March 1, 1972. It was moved by Mr. Ice and seconded by Mr. Cragan that this request be granted. Motion carried unanimously.

Mr. Wayne Kellum, Zoning Administrator, appeared before the Board to request a six month length of service salary increase for clerk in his office, Theresa Hodson. The request was for a \$10 per month increase to be effective March 1, which would make Miss Hodson's salary \$170 per month on a half-time basis. It was moved by Mr. Cragan and seconded by Mr. Ice that this request be granted. Motion carried unanimously.

Engineer Sanderson appeared before the Board with copies of a proposed agreement with Douglas County and the consulting firm of Finney and Turnipseed. The agreement relates to engineering services, field surveys, and plans necessary for determining right-of-way requirements on the West 23rd Street extension between the U. S. Army Corps of Engineers access road and the Northeast corner of the NW $\frac{1}{4}$ of Section 8, T13S, R19E. The proposed agreements sets out that these services will be provided for a lump sum amount of \$1,800. After due discussion it was moved by Mr. Cragan and seconded by Mr. Ice that the proposal as presented be accepted. Motion carried unanimously.

Finney & Turnipseed
for services
concerning a
bridge over
tributary of
Captain Creek
on F.A.S. Route
1277*

Engineer Sanderson presented to the Board copies of proposed agreement presented by consulting firm Finney and Turnipseed covering field surveys, designs, plans, specifications, and construction documents and engineering services for construction of a bridge over Captain Creek and a bridge over a tributary of Captain Creek on F.A.S. Route 1277 near the North line of Section 15, T14S, R21E. The proposal sets out cost for total plans including submission of final plans the sum of \$5,750, that for the establishment of center line stakes, slope stakes, grade stakes, and for the staking of all right-of-way per diem cost but not to exceed \$1,500, and for supervision during construction various per diem cost but not to exceed \$9,750. The last item referring to construction supervision would be at option of Douglas County. After due discussion it was moved by Mr. Ice and seconded by Mr. Cragan that this proposal be accepted. Motion carried unanimously.
