Lone Star Lake;  
Insurance on  
buildings

Mr. Howard Hurwitz, representing the insurance firm of Holmes, Peck and Brown which firm has carried the insurance on Lone Star Lake buildings, appeared before the Board with final figures relative to renewal of that insurance. Mr. Hurwitz related that a total evaluation of \$31,800 has been placed upon the various buildings and that the premium on this amount of insurance for a three-year contract would be \$1,441. It was moved by Mr. Ice and seconded by Mr. Cragan to insure the buildings at Lone Star Lake for this amount and prepay the amount of \$1,441.
