The East 113.6 feet, more or less, of the following described tract:

Beginning at a point 750.4 feet west of the Northeast corner of the South 10 acres of the East one-half (E½) of the Southeast quarter (SE¼) of Section 5-13-20; thence West on the 10 acre line, 163.6 feet; thence South to the North right-of-way line of Kansas State Highway No. 10, 265.91 feet; thence East along said right-of-way line 163.6 feet; thence North 264.73 feet to the point of beginning, less .177A D266/309. Commonly known as 2176 East 23rd Street.

It was moved by Mr. Cragan and seconded by Mr. Ice that Resolution No. 72-15 be hereby adopted. Motion carried unanimously. The zoning order is to become effective upon publication of same and Mr. Kellum will take responsibility for publication.

Board noted receipt of official notice from Dennis Kallsen, Assistant Manager of the City of Lawrence, that the Board of Commissioners of the City of Lawrence had appointed Messrs. Jack Rose, George Williams, and Robert Dark to serve as viewers for the proposed improvement of a road known as County Road 699B from Louisiana to Iowa Street.

Board noted receipt of a petition signed by John W. Hagen, Ernest Tuckel, Helen C. Rice, Charles Shuck, Solon J. Markley, Lloyd Shuck, Ivan Flory, William Markley, and Garland Graham requesting admission of certain properties to Rural Water District No. 2. The petition was referred to County Counselor Young for his advice and for his consideration.

Board noted receipt of a communication from Mr. Dennis Kallsen, Assistant Manager of the City of Lawrence, requesting that Douglas County participate equally with the City of Lawrence in financing 50% of the cost of acquiring an ambulance to be operated by Citizens Ambulance Service. The communication indicates that a grant is being requested which would supply 50% of the total cost. The request from Mr. Kallsen indicates that 50% of the total cost would amount to approximately \$3,500, which would make the county's share \$1,750. It is indicated that if a new ambulance can be provided in this manner, that this will satisfy the need for additional subsidy to the ambulance service for the immediate future. It was moved by Mr. Ice that inasmuch as it is evident that additional subsidy is required by Douglas County to maintain a present ambulance service, and inasmuch as indications are that participation in the funding of a new ambulance will satisfy the immediate subsidy requirements, that we participate to the extent of one-half of the local cost or approximately \$1,750 in this grant request. Motion was seconded by Mr. Cragan and carried unanimously.

Board noted receipt of the January 18 meeting of the Douglas County Welfare Advisory Board.

No further business, the Board adjourned to meet on Wednesday, March 22, 1972.

The Board agreed to take immediate steps to make this information available.
