The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board present.

Approved the minutes of the meeting of April 17, 1972.

Board noted approval of Commissioners Cancellation Orders No. 16, 17, 18, 19, 20, 21, and 22 to the Sheriff and Treasurer.

The Board approved Commissioners Cancellation Order No. 987. Order is on file in the office of the County Clerk.

Engineer Sanderson appeared before the Board with information that the consulting firm of Finney and Turnipseed had informed him that a recomputation relative to bridge C-72(4) on county road No. 1029 has shown that bridge to be deficient to the extent that it needs to be immediately replaced. Engineer Sanderson indicated that with this information he proposed to immediately build a detour around this bridge and to begin immediately with the construction of this bridge which will be accomplished by county workmen.

Engineer Sanderson presented the Board copies of request to the State Highway Commission of Kansas to proceed with field checks on F.A.S. Route No. 1375 from U. S. Highway 59 to F.A.S. No. 210. After due discussion it was moved by Mr. Ice and seconded by Mr. Cragan that this request to the State Highway Commission be approved. Motion carried unanimously.

Board noted receipt of a notice from the Executive Board of the Douglas County Agricultural Extension Council of a budget meeting to be held at the Holiday Inn on May 1, 1972 at 12 noon.
