Engineer Sanderson and Consultant Representative John Frazier discussed with the Board their findings relative to bids received on May 24 for construction of bridges over Captain Creek and a branch of Captain Creek, and grading related thereto on County Road No. 460. Following discussion and after consideration of the opinion on the matter from Counselor Young, the following action was taken. It was moved by Mr. Ice that all bids for the grading contract be rejected in that all grading bids were either tied to bids on bridge construction or were in excess of the Engineer's estimate on grading, and that the contract for construction of the two aforementioned bridges be awarded to the low bidder for the construction of both bridges. The low bidder being Frisbie Bridge Company of Topeka, Kansas with a bid of \$25,923.10 for the Captain Creek branch bridge and a bid of \$47,891.30 for the Captain Creek bridge, making a total combined bid of \$73,814.40. It was seconded by Mr. Heck and carried unanimously. The Board noted that the low bid was under the Engineer's estimate. The Engineer's estimate on the Captain Creek branch bridge being \$30,456.40 and on the Captain Creek bridge \$50,711.52 for a combined total of \$81,167.92.

Mr. Orville Flory, representing the proposed Wakarusa Rural Water District, appeared before the Board to ascertain Douglas County's interest in making water available to Wells Overlook Park from lines of the proposed water district. Following due discussion it was moved by Mr. Ice that Douglas County participate in the preliminary development costs of this district inasmuch as available water should prove to be a highly desirable asset to Wells Overlook Park. It was further moved that a warrant in the amount of \$25 be issued to Wakarusa Rural Water District, that amount being the required deposit to defray expenses of the preliminary study. Motion was seconded by Mr. Heck and carried unanimously.
