The Board received from the office of Assessor Darwin Rogers a certified copy of the Abstract of Population of Douglas County for the year 1972. The abstract shows that the total county population is 54,809 persons. A copy of the abstract will be on file in the office of the Douglas County Commission.

The Board noted receipt of a copy of a letter from Engineer Sanderson to Mr. Paul Barber, Chief of Engineering Division of the Army Corps of Engineers, setting out standards of the various classification of county road construction. This information was necessary relative to relocation of roads in Douglas County necessitated by Clinton Lake construction.

The Board noted receipt of a Joint Public Notice from the U.S. Army Corps of Engineers and the Kansas State Department of Health that the Holliday Sand and Gravel Company is requesting permission to establish a sand dredging and processing operation on the Kansas River directly west of the intersection of U.S. 24-40 and U.S. 59. The notice requests comments from any individual or governmental body relative to this request. The Board took the matter under advisement relative to any comment they may have.

The Board noted receipt of a communication from Forrest L. Swall, Chairman of the Douglas County Committee on Correctional and Jail Facilities, to the effect that he suggests two additions to the committee; namely, Mrs. Linda Kohlman and Mrs. Elizabeth Landers. Dr. Swall indicated he will make further contacts previous to recommending these appointments.

Darlene Hill, Budget Director, presented the Board with statement of fund balances as of June 30, 1972 and a statement of expenditures and balances of budget appropriations for the period January 1, 1972 to July 17, 1972.
