Delbert Mathia, County Clerk, requested consideration by the Board of the reclassification of Patty Jaimes, bookkeeper employed in his office. Mr. Mathia specifically requested that as January 15, 1973, Patty Jaimes be classified as a special consultant in charge of state and federal funded programs on a permanent half-time basis at a salary of \$3.20 per hour.
